KEDIA ADVISORY SERVICES India's Turmeric Market 2024–25: Supply Swings, Farmer Protests, and Price Outlook



India's turmeric market in 2024–25 has witnessed sharp swings driven by fluctuating supply dynamics and evolving domestic and global demand. Prices had plunged to around ₹11,200 per quintal in February 2025, pressured by heavy arrivals of over 25,000–30,000 bags per day in key mandis such as Nizamabad and Erode during the harvest peak. A significant 15–20% jump in production, particularly in Maharashtra, Telangana, and Karnataka due to favourable weather and expanded acreage, contributed to the supply surge. Simultaneously, weak demand from masala companies and slow export movement from Gulf countries and Bangladesh intensified the downward pressure, triggering over 14% correction in NCDEX April futures from January highs. However, a swift price rebound followed farmer protests in Telangana, including Rasta Roko rallies in Metpally, which disrupted arrivals and reignited bullish sentiment. Farmers' discontent with low prices led to delayed supplies, and expectations of fresh FMCG sector buying in the new financial year added further support.

Despite the strong output recovery to 78.30 lakh bags from 58 lakh bags in the previous year, yield losses of 10–15% and harvesting delays caused total arrivals to fall by 43.59% YoY to 38.08 lakh bags, while overall supply declined 13.76% to 88.14 lakh bags. On the demand side, domestic consumption is forecasted to rise 7.61% to 70 lakh bags, bolstered by heightened health awareness and wedding season demand, with 53 lakh marriages expected in 2025. On the export front, turmeric shipments are projected to drop 15.51% YoY to 27.38 lakh bags, primarily due to a 55.46% slump in Iranian demand and subdued momentum at the February 2025 Gulfood event. However, positive export trends to Bangladesh (+8.84%), the U.S. (+22.73%), and Malaysia (+23.96%) show promise. A significant 86.12% YoY decline in closing stocks to just 5.75 lakh bags, combined with tightening supply and strong festival-related demand, is expected to support prices in the coming months.

Technically, turmeric has completed a bullish harmonic pattern (XABCD) and is trading above the 50-day moving average with strong momentum. A MACD bullish crossover and rising RSI at 59 reflect renewed buying interest, while the price has retraced above the 61.8% Fibonacci level near ₹13,282, indicating a potential continuation toward the 200-day MA. It is recommended to create a buy position at around ₹13,000 with a strict stop loss of ₹12,200, targeting ₹14,600 for the coming month.

India's Jeera Market 2024–25: Balanced Domestic Demand, Export Challenges, and Price Outlook



India's jeera market in 2024–25 reflects a balanced outlook driven by stable domestic demand and improved arrivals, though export sentiment has turned cautious. Production is expected to dip by 3% to 100 lakh bags from 103.09 lakh bags last year. However, favorable harvesting conditions have led to better early-season arrivals between April and July compared to the previous year, offering relief to traders and processors.

Despite earlier optimistic projections, jeera exports are facing growing pressure. China's cumin purchases have slowed amid its economic downturn, while looming U.S. tariffs under President Trump's "reciprocal" trade stance have further clouded global trade sentiment. Heightened geopolitical tensions in the Middle East, particularly involving Iran, have added uncertainty, prompting global spice buyers to hold back. Additionally, the Indian rupee's recent appreciation—its best monthly gain in over six years—has reduced the price competitiveness of Indian jeera in international markets, affecting demand from key buyers like China, Bangladesh, and the UAE.

Domestically, consumption remains steady at around 40 lakh bags, offering a cushion against export volatility. Closing stock levels have increased, lifting the stock-to-use ratio to 64.76% from 58.14% a year ago. Technically, jeera has shown a bullish breakout above the 50-day moving average, supported by volume expansion and positive momentum indicators. Short-term price support may come from rising March-April temperatures impacting yields, but upside may remain capped unless global demand improves.

Technically, Jeera has broken out of the falling channel pattern and is trading above the 50-day moving average with bullish momentum, as indicated by a MACD crossover and RSI near 70; volume expansion also supports the strength. With crucial support near ₹21,705 and resistance around the 200-day moving average at ₹25,975. It is recommended to create a buy position at around ₹2500 with a strict stop loss of ₹21600, limited upside for the April month max towards ₹23500/23800 for April month.

India's Dhaniya Market 2024–25: Supply Constraints, Export Weakness, and Price Outlook



India's dhaniya market in 2024–25 is undergoing structural adjustments amid tightening supply, volatile export performance, and stable domestic consumption. Production is estimated to decline by 11.82% to 97 lakh bags, down from the previous year, while carry-forward stocks have sharply contracted by 68.49% to just 22.07 lakh bags. Although acreage in Madhya Pradesh has seen a slight drop, steady sowing in Gujarat and Rajasthan has partially balanced the shortfall. However, the overall market supply has reduced by 35.53%, intensifying supply tightness. While March 2025 arrivals stood nearly flat YoY at 76,791.86 tonnes, total annual arrivals plunged to 292,024.60 tonnes from 543,876.04 tonnes in 2023–24, reflecting lower availability in the market.

Domestic consumption remains firm, with a modest rise of 0.42% to 145 lakh bags, backed by robust demand during the 2025 wedding season, which is projected to witness 53 lakh weddings. However, exports have suffered a sharp decline—dropping 50% to 43,609.44 tonnes between April and December 2024, while export earnings fell 39% due to weak demand from traditional buyers such as China, Bangladesh, and the U.S. Diversification into markets like Sri Lanka, UAE, Oman, Canada, and Australia has helped cushion some of the export shortfall. Imports too have dropped significantly from 5.72 lakh bags to just 0.69 lakh bags, restricting any external supply support. The stock-to-use ratio is forecasted to remain in negative territory at -25.89%, signaling a constrained supply environment that may underpin prices going forward. However, factors such as cash flow constraints, muted processor demand, cheaper overseas alternatives, and the seasonal rise in arrivals post-April could weigh on price growth. In the short term, prices are expected to remain supported due to supply constraints, though gains may be limited by liquidity concerns and export weaknesses.

Technically, dhaniya is forming a base near crucial support at ₹7,756, bouncing within a falling channel pattern while holding above the recent lows. MACD has shown a bullish crossover, RSI is at 38 indicating room for upward movement, and price action suggests a potential short-term rebound. It is recommended to create a buy position at around ₹7,800 with a strict SL of ₹7,600, targeting ₹8,250 for the coming month.

As you are aware, as per the terms and conditions for grant of Certificate of Registration as Exporter of Spices (CRES), issued in accordance with the Spices Board (Registration of Exporters) Regulations 1989 and subsequent

Amendments, every Registered Exporter of spices should submit the Export/ Purchase/ Import Return in the prescribed format to Spices Board on quarterly basis on or before the 10th day of every succeeding quarter.

A 'Nil' return for corresponding quarter, should be submitted even though there is no Export/ Purchase/ Import.

Accordingly, all the Exporters are required to furnish all the pending Quarterly Export Returns for the year 2022-23, 2023-24 and 2024-25 on or before 25 $^{\rm th}$ April 2025. In this regard, the Quarterly Export Returns can be submitted online the link to submit the export/ purchase/ import return is $\frac{\rm https://indian\ spices.org.in/\ ESS\ /\ users/\ login\ /\ userhome}$

In exercise of the powers conferred by Section 5 of the Foreign Trade (Development and Regulation) Act, 1992, read with Para 1.02 of the Foreign Trade Policy 2023, the Central Government hereby notifies, in partial super-session of Notification No. 32/2024-25 dated

30.09.2024, the following:

1. The support under the Remission of Duties and Taxes on Exported Products (RoDTEP) scheme for export of products manufactured by Advance Authorizations (AAs) holders, Special Economic Zones (SEZs), and Export-Oriented Units (EOUs) stands extended only up to

05.02.2025.

Effect of this Notification: The Support under the RoDTEP Scheme for exports of products manufactured from AAs, SEZs, and EOUs has been extended up to 05.02.2025. However, from 06.02.2025 onwards, exports from these categories will no longer be eligible for RoDTEP support. The support under the RoDTEP Scheme for other categories (DTA) shall continue as per Notification No. 32/2024-25.
